What Is Extra Help?

Extra Help is a program to help eligible people pay Medicare Part D prescription drug costs, including premiums, deductibles, and coinsurance.^{1,2}

Are There Income and Asset Limits for Extra Help?^{1,3}

Below are the Medicare Extra Help income and resource limits for 2025 that the Social Security Administration uses to determine eligibility.

You can consider applying for Extra Help if you are below these thresholds for income and assets:

	Income	Assets
Single	\$23,475	\$17,600
Married	\$31,725	\$35,130
